TAX PAYMENTS TO BE BANKED IN SPECIAL ACCOUNT (AMENDMENT OF SECTION 66).

Section 66 of the Principal Act is amended by repealing and replacing it with the following:

“66. GST TAX REVENUE PAYMENT AND DISTRIBUTION.

All revenue collected from the imposition of goods and services tax under this Act shall be paid and distributed in accordance with the provisions of the *Inter-Governmental Relations (Functions and Funding) Act 2009*.”.

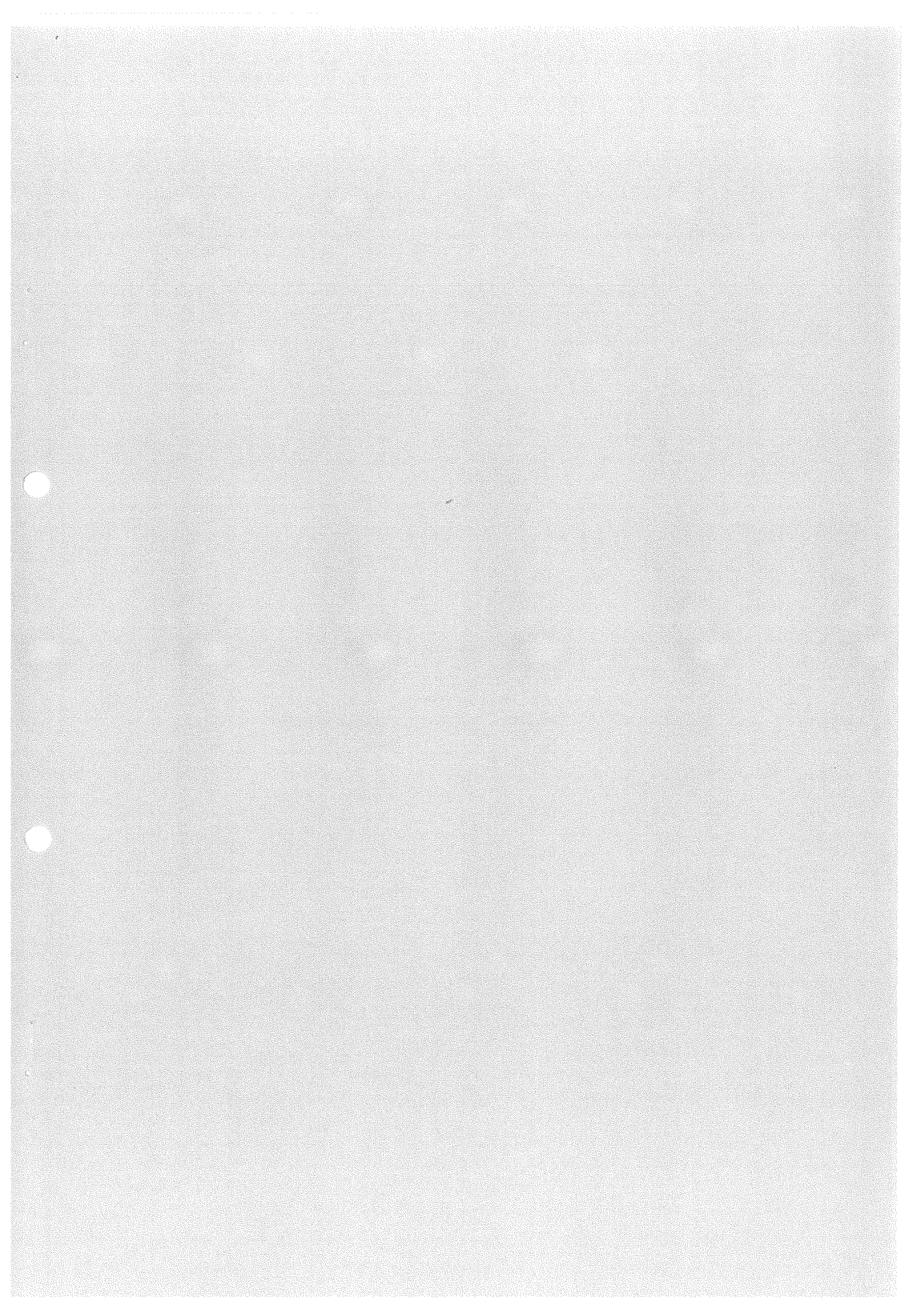

- (b) in respect of Section 3, to be deemed to have come into operation on 1 January 2014; and
- (c) in respect of Section 4, to come into operation on 1 January 2016.

1. REMOVAL OF COMMISSIONER GENERAL FROM OFFICE (REPEAL OF SECTION 6A).

Section 6A of the Principal Act is repealed.

2. COMMISSIONER OF TAXATION (REPEAL OF SECTION 6B).

Section 6B of the Principal Act is repealed.

3. SOURCE OF INCOME (AMENDMENT OF SECTION 196B).

Section 196B of the Principal Act is amended by repealing the words and figures "Section 196D(1)" and replacing them with the following word:

"Division".

4. INTERPRETATION (AMENDMENT OF SECTION 354K).

Section 354K of the Principal Act is amended in the definition of "eligible payment" by repealing Paragraph (b).

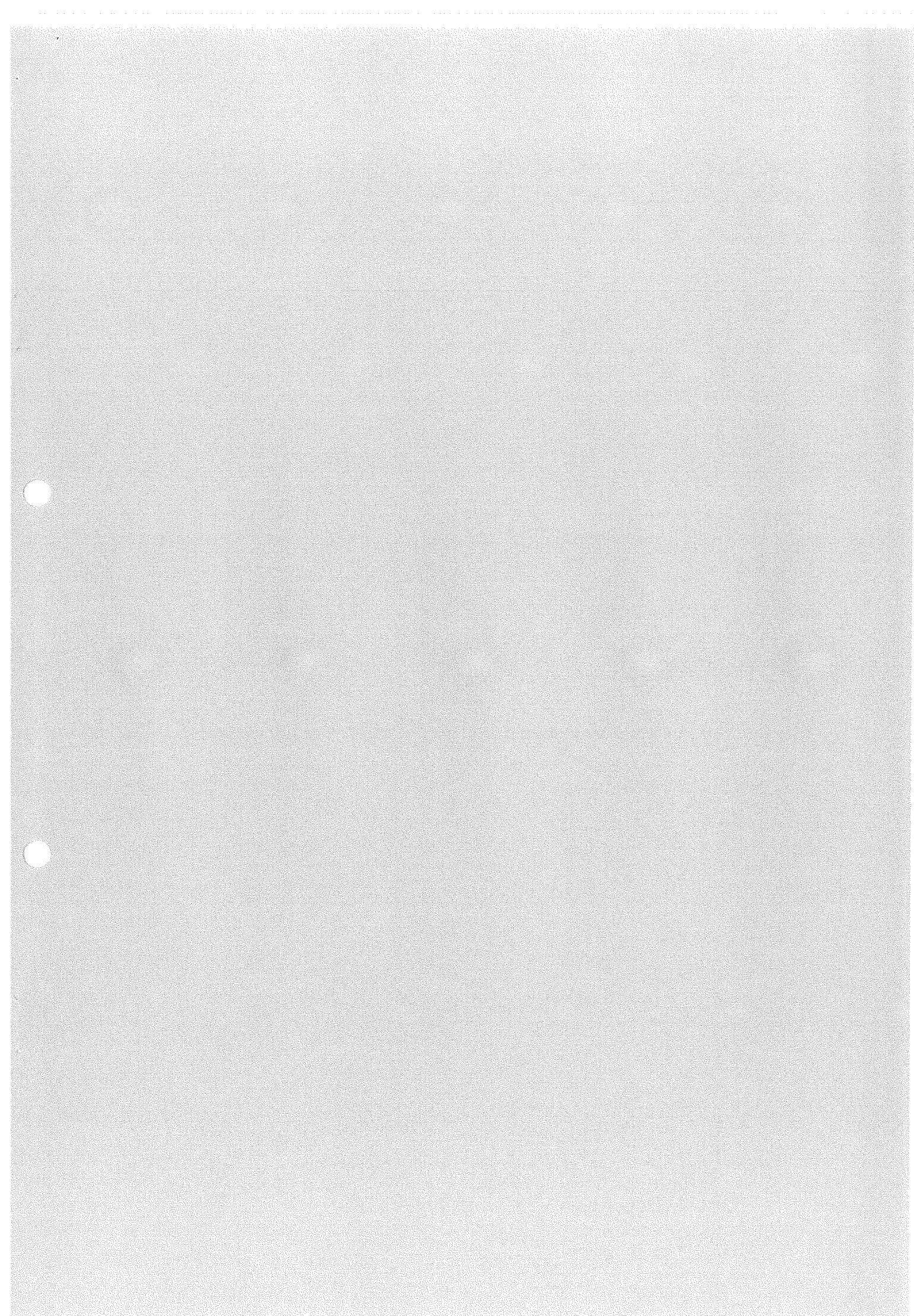

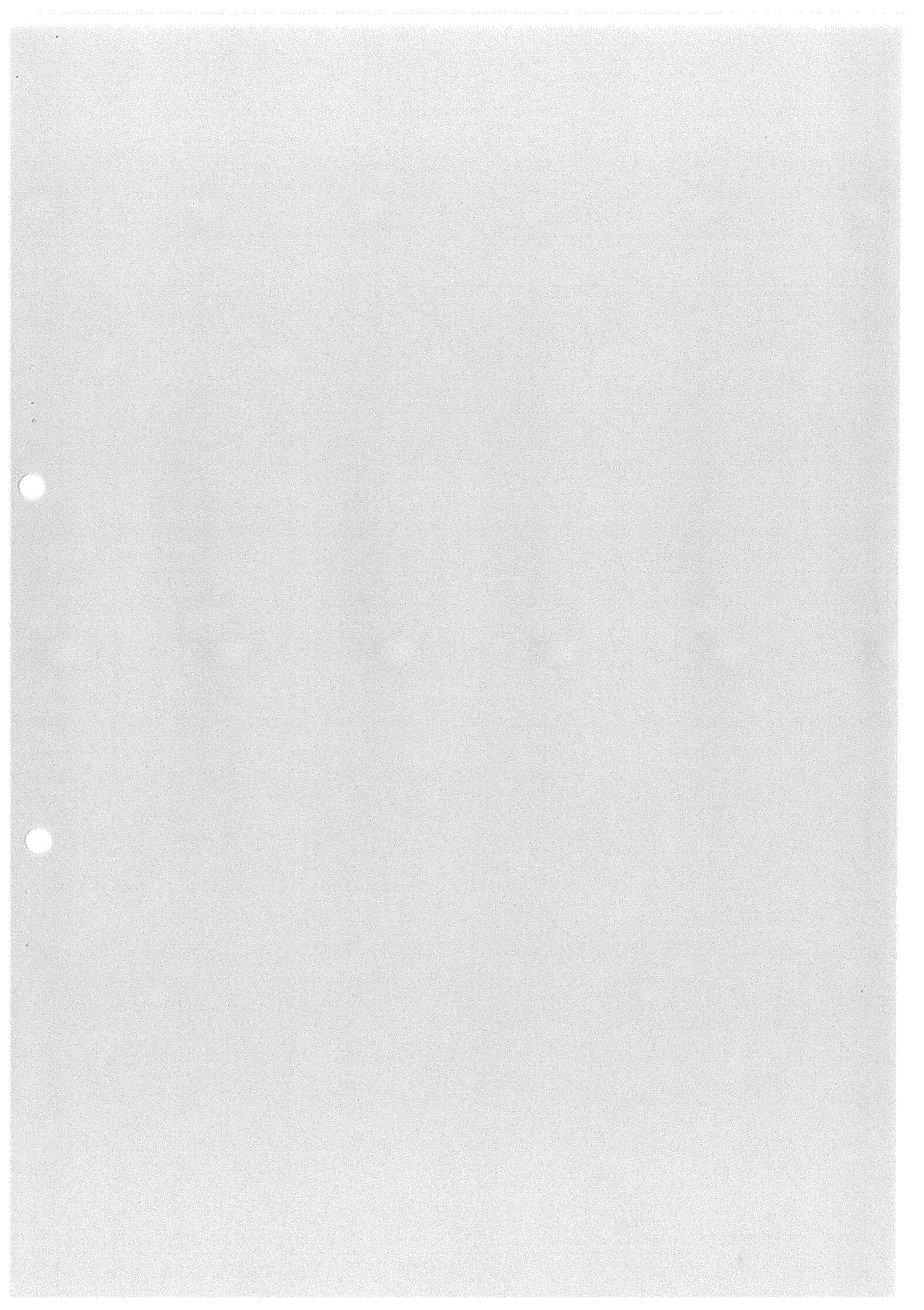
