The Government of Papua New Guinea Labour Mobility Unit (PNG LMU) is a project under Department of Treasury and the only mandated body that is authorized to facilitate the Pacific Australia Labour Mobility (PALM) and Recognized Seasonal Employer (RSE) schemes respectively in PNG. Unless consent is given by PNG LMU, any information concerning the schemes and the Unit should come directly from the PNG LMU and the respective partners.

All interested applicants who would like to participate must be between the ages of 21-40 and must also have a good personality (mas igat gutpla pasin). The nature of employment this program offers are mostly in the Agricultural sector hence, we encourage applicants to be physically fit and healthy.

In addition to that, they must have the following mandatory documentation:

1. Birth Certificate/NID Card
2. Passport
3. Police Clearance
4. Covid 19-Vaccine Card

Each applicant must register under their respective Districts or Provinces that are endorsed by the PNG LMU.
